Six water quatiliy tests were completed, 1 in Erath County, 2 in Comanche County, 1 in Bosque County, and 2 in Coryell County. One Coryell County well tested high in salinity. All wells tested negative for bacteria.
- 12. Education/Public Relations Report was given by Stephanie Keith.
- 13. Manager's Report was given by Joe Cooper.

- 14. The Current Tax Rate and Percent of Revenue Collected was reviewed. 95% of the total revenue for 2020 has been collected.
- 15. Second Review of the 2021 Budget was given by Crystal Eberhart.
- 16. There was discussion on the annual contract with Boucher, Morgan, and Young, CPA. Frank Volleman made a motion to accept the annual contract with Boucher, Morgan, and Young. Second by Kenneth Bullington. All members present voted yes.
- 17. The Regular Election for Directors from Comanche and Erath Counties to be held November 3, 2020 was discussed. The last day to file is August 17th, 2020 and the last day to write-in is August 20th, 2020. Barbara Domel made a motion to order the election, second by W.B. Maples. All members present votoed yes.

The first Thursday in September falls right before Labor Day Weekend, there was discussion on moving the September Board Meeting to the second Thursday in September.
