- 15. GMA 8 Joint Planning Update was given by Crystal Eberhart. WSP (formerly LBG-Guyton) was approved by GMA 8 board of directors to guide and develop Desired Future Conditions. A contract committee was appointed to negotiate the contract with WSP.
- 16. Complete Annual Report on Achievement of MTGCD Management Plan Objectives was presented to each board member for the chance to review.
- 17. Discussion of having Ty Embry of Lloyd Gosselink Rochelle & Townsend, P.C. provide Legislative Representation for MTGCD during the 86th Texas Legislative Session was heard. Motion made by Joe Altebaumer and second by Shane Tucker to approve \$5000.00 per month for the six months of legislative activity for a total of \$30,000.00 for January 1 through June 30, 2019.
- 18. Discussion on renewing MTGCD sponsorship for the 4-H Water Ambassador Program was heard. It was agreed to double last year's donation. MTGCD will provide \$3000.00 for 2019 sponsorship. In addition to the annual sponsorship discussion on providing all cost for Tier 2 Ambassadors, Mila and Sersha. Tier 2 cost will be \$250.00 for each ambassador. Motion was made to approve the 2019 sponsorship and scholarship for Tier 2 costs by Joe Altebaumer and second by Shane Tucker.
