- 8. Check Detail Report reviewed for dates 5/1/2019 through 5/31/2019, for check numbers 9875 through 9912, and including electronic checks numbered 19155, 19531, 43019, and 51419. Check number 9912 was voided. Motion was made by Jerry Hinshaw, second by W.B. Maples, to approve and ratify the payment of the bills. All members present voted yes.

All wells tested negative for bacteria. Erath County wells were monitored in May and Comanche County wells will be monitored in June.

- 14. Manager's Report was given by Joe Cooper.
- 15. Joe Cooper gave a Legislative Update.
- 16. Joe Cooper gave a GMA 8 Update.

- 17. Discussion/Possible Action on Consolidation of Bank Accounts tabled until July meeting
- 18. There was discussion on the purchase of the lot adjacent to the MTGCD office. Stephanie Keith went over the benefits to schools, the community, and the District. The Board retired into Executive Session pursuant to Texas Government Code, Section 551.074, for further discussion.
