Two water quality tests were completed, both in Erath County and both tested good. Comanche County wells were monitored in the month of October and Coryell County wells will be monitored in November.

- 13. Manager's Report was given by Joe Cooper. The revised management plan has been sent to TWDB. There has been a partial delivery of the Major Rivers Program materials.
