Rules MTGCD believes have been violated or are being violated:

- 1) Failure to register water well (MTGCD Rule 5.2(a));
- 2) Failure to report driller's log (MTGCD Rule 5.4(f) and Rule 5.16);
- 3) Failure to obtain an operating permit prior to drilling (MTGCD Rule 5.5(b));
